Non-Winners of a Grade I Stake since June 26, 2023 allowed 2 lbs. Non-Winners of a Graded Stakes since December 26, 2022 allowed 4 lbs. Highweights preferred followed by Graded or Group winners, Grade or Group placed horses, followed by Stake winners, Stake placed horses and horses with the highest Non-Claiming earnings at the time of entry. Graded or Group winners have first preference regardless of weight. Starters to be named through the entry box by the closing time of entries. A trophy will be presented to the winning owner.
